**AND**

Asmita Law College having their address at Kannamwar Nagar II, Vikhroli, Mumbai, Maharashtra 400083 (hereinafter referred to as "the **PARTY OF THE SECOND PARTY**")

WHEREAS the Party of the First Part and Party of Second Part are collectively referred to as the said Parties.

AND WHEREAS the Parties wish to initiate collaboration in the field of education through academic programs supported by the University of Mumbai, the Bar Council of India (BCI), and the University Grants Commission (UGC).

AND WHEREAS the said Parties recognize their strengths in Research and Education in the discipline of Law and their mutual interest in engaging themselves in academic operations.

AND WHEREAS the Parties hereby agrees to collaborate for the temporary period of 5 years which shall commence from 2021 and the same shall expire on 2025.

**NOW THIS AGREEMENT WITNESSETH THAT:**

**Objectives**

This Memorandum of Understanding (hereafter referred to as the "MOU") intends to set out the general principles of mutual cooperation in the field of education, according to which the Parties may jointly identify areas of mutual interest and carry out cooperative activities on the basis of reciprocity and mutual benefit.

**Scope of Cooperation**

The Parties hereby agree that they will encourage the following cooperative activities, in particular:

- a. Exchange of information on research, teaching, learning materials and literature relevant to research programs through webinars, Legal Training, Legal aid, Guest lectures by the expertise as well as offering Courses in Multiple discipline in the field of Law.
- b. Giving opportunities to attend seminars, Faculty Development Programs (FDP), conferences, workshops and short-term programs in the area of research through the expertise in the field of recent development, amendments in law, while extending invitations to each other's faculty to participate therein.
- c. Other areas as mutually agreed upon by the Parties.

**Implementation and Funding**

The Parties hereby mutually agree that the cost of cooperative activities may be funded as mutually determined. All cooperative activities under this MOU will be subject to the availability of funds to the Parties.

**Dispute Settlement**

The Parties hereby agree that they will consult together upon request of either party regarding any matter relating to the terms of this MOU and will endeavor jointly in a spirit of cooperation and mutual trust to resolve any difficulties or misunderstandings which may arise.

**Amendment**

The Parties hereby mutually agree that this MOU may be amended by the Parties with the written consent respectively.

**Compliance with Law**

The parties specifically intend to comply with all applicable laws, rules and regulations as they may be amended from time to time. If any part of this Agreement is determined to violate national, state, or local laws, rules, or regulations, the parties agree to negotiate in good faith revisions to any such



provisions. If the parties fail to agree within a reasonable time to revisions required to bring the entire Agreement into compliance, either party may terminate this Agreement upon thirty (30) days prior written notice to the other party.

#### Entire Agreement

This Agreement constitutes the entire agreement and understanding between the parties as to the subject matter hereof and supersedes all prior discussions, agreements and undertakings of every kind and nature between them, whether written or oral, with respect to such subject matter. This Agreement may subsequently be modified only by a written document executed by both parties.

#### Duration and Evaluation

This MOU will come into effect on the date of signature by the representatives of the two institutions. Either party may request termination of this agreement, in writing, Thirty (30) days prior to the proposed termination date. Any activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed in writing. A joint evaluation of the MOU will be initiated by the designated representatives Three (3) months prior to the expiration date. Following the evaluation, the MOU may be renewed and resigned for an additional five (5) year period.

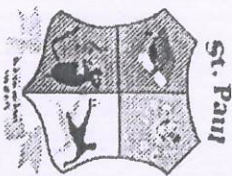

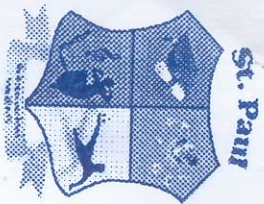

## COLLABORATION AGREEMENT

Exchange of Faculties and Student Skill Development.

Between

And

effective as of 10<sup>th</sup> August 2022 to establish an affiliation by and between St. Paul College, Ulhasnagar-04, hereinafter referred to as the FIRST PARTY. And ASMITA LAW COLLEGE, VIKROLI hereinafter referred to as the SECOND PARTY for the purpose of Exchange of Faculty and Student Skill Development.

The aforesaid institutions are hereinafter referred to individually as institute and collectively as institutions.

### Preamble

WHEREAS, St. Paul College and, ASMITA LAW COLLEGE, VIKROLI has many areas of common interest, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, education and research.

NOW THEREFORE, St. Paul College and ASMITA LAW COLLEGE, VIKROLI have decided to enter into collaboration for the cooperation of the two institutions set out in the following Articles.

### ARTICLE 1: OBJECT

Both Institutes agree to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity.

The two parties shall seek to promote:

#### 1.1 Faculty/Staff Exchanges

- (i) Organizing, participating in workshops, seminars, Faculty Development Programs, Interdisciplinary conferences, symposiums, and other types of academic discussions on mutually agreed upon topic

A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration will be agreed.

## 1.2 Students Skill Development Programs

- (i) To guide and exchange information on research and educational programs,
- (ii) To jointly organize short-term continuing education programs, Student Development Programs on topics of mutual interest,
- (iii) To organize seminars jointly, conferences, or workshops on topics of mutual interest,
- (iv) To propose and engage jointly in research or training programs sponsored by funding agencies or corporates
- (v) To give career guidance to students and provide training assistance for placements
- (vi) To jointly organize job fairs for the benefit of the students

Terms and conditions for each visit or an assignment or such exchange, including those concerning remuneration per visit/lecture, travel allowance (if applicable), will be worked out between the institutes.

St. Paul College and ASMITA LAW COLLEGE, VIKROLI agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by both the institutions. These terms shall include a brief description of the proposed activity, financial arrangements, and person(s) responsible for its implementation.

## ARTICLE 2: COORDINATION

Each institution shall appoint one member of its teaching/research faculty to coordinate the program on its behalf. Further, a coordination committee consisting of a program coordinator from the side of St Paul College and ASMITA LAW COLLEGE, VIKROLI a program coordinator from the side of, will periodically review and identify ways to strengthen cooperation between the two institutions

## ARTICLE 3: VALIDITY

The collaboration shall remain in force for a period of 2 years commencing from 10<sup>th</sup> August, 2022. Institutions may extend the term by written agreement signed by both after review.

## ARTICLE 4: TERMINATION

Either institution may terminate the collaboration by giving written notice of one month in advance to the other institution. Once terminated, neither **St. Paul College** nor **ASMITA LAW COLLEGE**, **VIKROLI** will be responsible for any losses, financial or otherwise, which the other institutions may suffer. 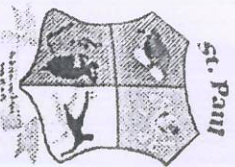

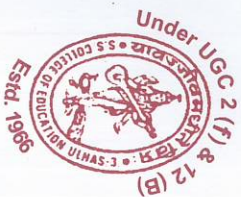
