## Syllabus Drafting, Pleading and Conveyancing-I

### LL B Semester II / Semester VI BLS LLB

#### Course Objectives

Good speaking and the writing skills are required for the lawyers. The objective of the course is to train the students with skills to draft the essential legal documents. It also intends to acquaint the students with advocacy skills to bridge the gap between theoretical and practical knowledge and to strengthen and enhance their critical thinking. This course intends to impart the essential skills enabling the learner to understand and draft the legal documents that he/she may come across in his/her professional as well as day to-day life. It helps in making aware the learner to the critical rules and principles of drafting legal documents essential not only in professional life but also in day today life.

Bar Council of India has prescribed one course on Drafting, Pleading and Conveyance as a compulsory clinical course. However, to give a winning edge to students of the University there will be three courses on drafting, pleading and conveyancing. This is the first of the three on drafting. Drafting skills are absolutely important for a lawyer and so in-depth coverage and vast coverage of the subject is the primary objective. The purpose of this course is to impart knowledge in drafting simple letters and of documents/pleadings which are related to the courses students study in the first year. The objective of the course is to teach in detail the content and format of the drafting of the items included in the four modules.

### Recital of the Case:

Brief introduction of what the case is about and its context

Certain documents were executed between the appellant firm and the ~~respondent~~ respondent company in respect of premises of which the latter was a tenant.

According to the appellant these documents were intended to effect a sublease of three portions of the premises in question though in order to avoid consequences under the Delhi and Ajmer-Merwara rent control act 10 of 1947, they apparently purported to create a partnership.

The trial court held that the documents executed by the parties evidenced an agreement for a sub-lease and since the agreement did not require registration, the firm was entitled to the reliefs claimed by it on the basis of the agreement.

This case is a clear exposition of the doctrine of 'part performance' in Indian law.

The case is related to an unregistered sublease purported to have been executed by the respondents in favour of the appellants and the premises said to have been given possession of to the appellants and from where they were forcibly dispossessed by the respondents.

### Facts of the Case:

Detailed account of the events, actions, and situations that led to the litigation

The first appellant, Delhi Motor Company, was a partnership firm, of which the other four appellants were partners.

The main respondent, the managing director of the New Garage Ltd - U. A. Bhatnagar.

According to the appellants, an agreement to sub-lease and an actual sublease in pursuance thereof was evidenced by three unregistered documents exhibited in the case.

The parties arrived at an agreement on February 22, 1950. The managing director had at that time, no power to enter into such an agreement on behalf of the company and so on March 22, 1950, a

resolution was passed by the board of directors authorizing the managing directors to enter into the transaction. Further it was alleged that Messrs Kamwar Brothers Ltd. vacated the other portion of the premises which also included vacated in the sublease, the respondents did not give possession of it to the appellants. The suit was decided in favour of the plaintiffs.

In appeal, the Punjab High Court held that the three documents constituted either an agreement to sublease. The Supreme Court of India passed the judgement on 8th

January 200 1968 as a Special leave appeal.

It stated that the agreement for partnership was never completed, so that the firm was not entitled to any relief at all.



**Ratio Decedent**

(The reason for the decision): The principle or legal reason which forms the basis of the judgment

Merely because the case was for an indefinite period and related to immovable property which was not used for agricultural or manufacturing purposes it could not be held to be a lease from month to month.
